



On Board Crew Rest

ON BOARD CREW REST

As per our Collective Agreement, crew operating long haul LOU 18/22 flights should take their full on board crew rest to ensure their own health and safety and that of the flight. If the Service Director needs to adjust the service to respect the required negotiated on board crew rest, a report should be submitted to the Company and copied to the union at office@local4092.ca. Please refer to the following Collective Agreement articles:

B14 **YYZ-TLV** **B14.01.01.03**

A minimum of **two (2:00) consecutive hours** onboard crew rest for flights with a block to block time equal to or greater than eleven hours and thirty minutes (11:30)

LOU 60.04.06 An extra 30 minutes is added to on board crew rest for LOU 18 and LOU 22 flights. This thirty minutes is **included** in the totals below.

LOU18 **YYZ-PVG, YYZ- PEK** **LOU 18.03.02**

On board crew rest will be a minimum of **two hours 30 minutes (2:30)** consecutive for a scheduled duty period of fourteen hours fifty nine minutes (14:59) or less.

On board crew rest will be a minimum of **four hours (4:00)** consecutive per operating employee when the scheduled duty day is fifteen (15) hours or more.

LOU 22A **YYZ-DEL, YYZ-HKG** **LOU 22.05.01**

On board crew rest will be **four consecutive hours (4:00)** per operating employee when the scheduled duty day is sixteen hours 16 minutes (16:16) to seventeen hours ten minutes (17:10).

On board crew rest will be **four hours thirty minutes (4:30)** consecutive per operating employee when the scheduled duty day is seventeen hours eleven minutes (17:11) to eighteen hours (18).

Meal breaks are to be taken separately.

Currently there are no flights scheduled under LOU 22B.

During the week of May 15, 2017 Air Canada will be hosting cabin crew focus groups in the Crew Centres. One of the topics they want to hear about is "**crew break rotations.**" We have filed **numerous grievances** on the issue of crew breaks on long haul flights, upon which the Company has **not yet acted**.
